Building Sewers (drains outside, prior to backfilling)

Building Drains (drains inside, prior to backfilling)

Framing, Heating Rough-in and Plumbing Rough-in (prior to insulating)

Insulation / Air Barrier / Vapour Barrier

Fireplace Rough-In (prior to damper installation)

Interior, Heating and Plumbing Final (prior to occupancy or use of equipment)

On-site Sewage Final (final grading and sodding complete)

Exterior Final (completion of exterior stairs, landings etc.)

This Permit has been issued pursuant to the Ontario Building Code Act. No person shall construct or demolish except in accordance with this Act

No person shall construct or demolish a building except in accordance with the plans, specifications and/or other documents on the basis of which this permit has been issued. Any deviation from those plans, specifications and/or documents shall be submitted to and authorized by the Chief Building Official prior to making such change.
